Subject: Reply regarding Payment and Implementation Matters related to File No: PS-03001/1/2023-PMC Pt-3 (E-32596).

Dear Sir/Madam,

This letter serves as a formal reply on behalf of the Gorkhaland Territorial Administration (GTA), West Bengal, concerning the matters related to the above-mentioned file number.

1. It is to be noted that **JeevShakti Products Private Limited** is NOT ACTING AS a private entity or miller but in its legal capacity as the **Nodal Agency** for implementation duly appointed and authorized by the **GTA, West Bengal**. The Implementing Agency has already made an upfront payment of **Rs.2,25,00,000.00** (Two Crores Twenty-Five Lacs Only) via RTGS on **17th September 2024**, under UTR: **ICICR52024091700423187**, to **NAFED's A/c No: 110144034290** in **Canara Bank**. This payment intimation was well communicated to the concerned authority, but no reply has been received to date regarding this matter.
2. It is stated in the Office Memorandum from Price Monitoring Division that the **GTA** shall lift the said stock in **three phases**, with each phase comprising not less than **4,500 MT**, with payments made in advance by the **GTA** itself, rather than through any private vendor or miller.
3. It is important to highlight that **NAFED** has already received payments from a **private party** on behalf of the **Tripura Tribal Areas Autonomous District Council**, and this transaction was not objected by the concern authorities. Therefore, there should be no self-contradictory business terms presented. The **DoCA** and/or **NAFED** do not possess the capacity to restructure the policies and procedures of business in this context.
4. There is no confusion on the duties and responsibilities of the implementing agency of **GTA** as this was well communicated and clarified in the letter Ref. No: DoAFW/GTA/03, Dated: 20th September 2023 (Copy of this letter is attached) that "the allocation of Raw Gram Chana 14000MT be coordinated in cooperation with M/s JeevShakti Products Private Limited, who will be responsible for deposit of amount, handling and processing."
5. Another letter dated 30th September 2024 vide Ref. No: DoAFW/GTA/07 was sent to The Secretary, DoCA stated that "GTA has no setup to lift the said stock and milling therefore it is requested to allow deposit of payments through the Nodal Agency i.e. M/s JeevShakti Products Private Limited in this connection."
6. Unless **NAFED** produces a formal communication in reply to the **DoCA's** order dated 27th September 2024, no effective date shall come into motion as per the defined terms.
7. Therefore, the **DoCA** shall direct **NAFED** to receive and accept the payments made from the account of **M/s JeevShakti Products Private Limited**, as it has been formally appointed as the **Implementing Agency** for the **GTA** and is empowered to act on behalf of the **GTA** for the implementation of the **PSF** scheme.
8. In this regard, the **GTA** also declares and undertakes that **JeevShakti Products Private Limited** is neither a **Private Vendor**, nor a **Miller**, nor associated with any outside private interest. **JeevShakti Products Private Limited** holds a clear legal identity as the **Nodal and Implementing Agency** for the **GTA**.

We appreciate your attention to this matter and look forward to your prompt response.
